However, in 2019, TNS Tobacco Company Ltd, the main importer of cigarettes in Mauritius, increased the price of all the brands that it imports and distributes by around MUR 5 which represents an increase of 2.12% to 3.33%

A National Steering Committee for Tobacco Control was set up in 2009 which comprise of key representatives from different ministries, civil society/ NGOs and other departments with the main aim of coordinating tobacco control initiatives, programmes and activities in Mauritius.

At the level of the Ministries and Departments, a focal point for tobacco control has been nominated in order to facilitate coordination and reporting.

Please provide a brief description of the progress made in implementing Article 5.1 and 5.2 (*General obligations*) in the past two years or since submission of your last report.

A National Action Plan for Tobacco Products (NAPTC) 2015-2018 has been validated and implemented with regards to different tobacco control programmes and initiatives planned during the stated year. A new NAPTC covering period 2021-2025 will be prepared this year to govern forthcoming tobacco control initiatives of the Ministry of Health and Wellness. It is to be noted that all the tobacco control initiatives of the Ministry of Health and Wellness are in line with the provisions of the WHO FCTC and the provisions of the Public Health (Restrictions on Tobacco Products) Regulations 2008. The second set of pictorial health warnings which has been pre-tested and launched in 2018 will be rotated over Plain Packaging of Tobacco Products which has already been agreed by the Cabinet of Ministers in 2018 and the relevant legislations governing same is in process of being amended. As Party to the Protocol to Eliminate Illicit Trade in Tobacco Products, the relevant articles of the Protocol are being implemented and our current legislation is also being amended to align its provisions with the philosophy of the said Protocol.

TI has never been able to interfere with the policy decision of the Ministry though they have tried by all means for instance for have a say in the amendments being brought to the current legislations. All requests from TI to meet Management to discuss matters pertaining to our TC policies have been turned down and proposals to set up manufacturing plants on our territory have been turned down

What are the priorities for implementation of the WHO Framework Convention on Tobacco Control in your jurisdiction?

- •The main priority for Mauritius is the amendment to the Public Health (Restrictions on Tobacco Products) Regulations 2008 with the technical assistance provided by WHO. This amended legislation will actually take on board other articles to the WHO FCTC which were not previously considered.
- The introduction of Plain packaging of tobacco products is the utmost priority for the Ministry with the amendment to the legislation whereby the relevant legislation will be adopted.
- Law enforcement will be reviewed and strengthened to ensure better compliance and enforcement actions.
- The banning for sale of ENDS and ENNDS and the importation of smokeless tobacco products are also challenging and will be another priority for the Ministry.
- Regulating the contents and emission of tobacco products and testing of the products will be considered as well as Article 10 will be implemented.
- Cross border advertising, as well as brand stretching, will be another priority for the Ministry.
- A new National Action Plan on Tobacco Control for the period 2021-2025 will be devised by the Ministry whereby the implementation of WHO FCTC will be taken on board.

- There is still a compelling need to devise a Taxation Policy for Mauritius as this will impact largely on our tobacco consumption.
